Scope of Work: General Terms and conditions

- 1. All the structures in the mill units shall be inspected block wise and necessary tests should be carried out as required in the respective aforesaid mills situated in Mumbai. The inspection shall cover all the works of engineering, construction, such as building, Tanks, scaffolding, platforms, Chimneys, Bridges, walls and supporting structural work stipulated by the chief inspector of Factories. if necessary to assess the scope of work and shall highlight the dangerous portion of the blocks from the safety point of view and suggest remedial measures.
- 2. The inspection shall be result in submission of detailed report and measures to strengthen all the week structures with special emphasis on prevention of collapse in the next five years, also in the report an indicative approximate estimated cost of repairs for such job will have to be indicated separately against the structures which reported to be week and need repairs.
- 3. The inspection report shall be submitted in triplicate for the guidance of the mill management (separately).
- 4. The stability certificate shall be prepared in required format of factory Rules 3A and submitted to the factory inspectorates with a copy to respective mill, well within the required time of 3 weeks.
- Issue Stability Certificate should be valid for 5 years i.e. from January 2016 to December 2020.
- 6. The mill units being old structure, it may not be possible to furnish all details. Mills shall extend full co-operation and shall try to furnish available drawings, Structural details etc. as far as possible. In such cases, you have to ascertain and collect such details on your own.
- 7. Updated block plan shall be furnished by the structural engineer. Block plan shall also show the block numbers. No. of floors and activity at each floor.

BLOCK PLAN OF THE MILLS

A) It may become necessary in case of insistence by the factory inspector to prepare plans of each block of the mill unit as per the requirement of the factory inspector.
